THE LONDON BOROUGH OF BARKING AND DAGENHAM (WAITING AND PARKING RESTRICTIONS) (OXLOW LANE AND RAINHAM ROAD SOUTH, DAGENHAM) AMENDMENT No. 129 ORDER 2024

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under sections 6 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act made the above Order, the effect of which will be to:

- 1. Introduce 'No Waiting at any time' restrictions at the following locations:
 - a. Oxlow Lane, south side, from a point 1.8 metres east of the extended common boundary of No's 271 and 273 Oxlow Lane for 11 metres in an easterly direction.
 - b. Oxlow Lane, south side, from a point 19.8 metres east of the extended common boundary of No's 271 and 273 Oxlow Lane for 14.8 metres in an easterly direction.
 - c. Rainham Road South, west side, from a point 15 metres north of the extended southern building line of No. 264 Rainham Road South for a distance of 33.7 metres in a southerly direction.
 - d. Rainham Road South, west side, from a point 32.3 metres south of the southern building line of No. 264 Rainham Road South for 5 metres in a southerly direction.
 - e. Rainham Road South, east side, from a point 1.3 metres south of the southern building line of No. 264 Rainham Road South for 19.7 metres in a southerly direction.
- 2. Revoke the 'Limited Waiting Mon-Fri 8.30am-5.30pm 1hr No return within 2hrs' bay on Rainham Road South, east side, from a point 1.3 metres south of the southern building line of No. 264 Rainham Road South for 2.1 metres in a southerly direction.
- 3. Revoke the 'No waiting Mon-Fri 8.30am-5.30pm' restriction on Rainham Road South, east side, from a point 3.3 metres south of the southern building line of No. 264 Rainham Road South for 17.2 metres in a southerly direction.
- 4. Revoke the 'No waiting Mon-Fri 8.30am-5.30pm' restriction on Rainham Road South, west side, from a point 15 metres north of the extended southern building line of No. 264 Rainham Road South, for a distance oof 52.5 metres in a southerly direction.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or any Regulations under it have not been complied with may do so within six weeks of the made date of the Order by applying to the High Court.
